North Yorkshire Police 101 or 999

Our Last Meeting: -

Our last meeting was held on 13 September 2017 and was very well attended by Member Parishes (2 apologies), 3 members of public and PS Craig Regan was in attendance as the Police representative.

Items for topic of discussion included: -

- Parking in the vicinity of Schools across 5 Member Parishes
- The Herbert Protocol
- The Community Impact Team (CIT)
- Hate Crime Awareness Week
- Call Centre issues
- Defibrillators
- Speeding/traffic volume concerns in an area of East Ayton

Herbert Protocol

Cllr Turner explained new protocols that are now in place to ensure that dementia sufferers are not arrested, they are placed in a safe environment with triage taking place within North Yorkshire Police Service to assess whether they are at risk; suitable medical facilities are then found as appropriate.

"The Herbert Protocol" is a simple risk reduction tool in the shape of a form containing vital information on a person with dementia; this information is then used should that person go missing to assist in finding them. Community Impact Team (CIT)

Lesley Philps of the Community Impact Team gave information and updates on the workings of the Team which is a multi-agency group taking an overarching to referred cases, i.e. more organisations working together can have more impact that one organisation trying to tackle issues alone.

Part of their work is Safeguarding (against terrorism) which includes giving advice on how to safely store fertilizer to working with schools to combat bullying, hate crime and radicalisation. Special Branch are also working with licensees to train on how to react/act in a terrorist situation; safe places are being created in the event of an attack. "Run, Hide, Report" is how to safely react to incidents. **Hate Crime Awareness week** takes place 14-21 October, for more information visit https://www.stophateuk.org/hate-crime-awareness-week/

Police Report

PS Regan introduced himself (he has recently returned to the Scarborough Rural Area) and explained that the Horse Fair had gone extremely well and in a joint Operation 11 (eleven) vehicles were stopped for having tax and insurance offences – a total of 17 vehicles were seized, some were not reclaimed and were therefore crushed.

Due to on-going Operations while the Horse Fair was taking place, there was a dramatic reduction in theft as Morrisons' supermarket had also been given target-hardening advice to reduce instances of shoplifting. New IT equipment is on the way to enable residents to have direct contact with Officers via smart mobile rather than going through the current procedure of asking to leave a message or email.

Priorities remain as Safer Road, Poaching and Fly-tipping and Dog Fouling; these haven't changed for over 10 years but this is because they continue to cause our areas problems.

Crime Breakdown – Seamer/Crossgates/Irton

- Theft of vehicle (recovered in Seamer 2 x males arrested)

Parking at Schools

This issue is becoming increasingly worrying for Schools, Police, Member Councils and parents alike! IF you live close to your child's school PLEASE walk them, don't take your vehicle –

- driveways are being blocked
- aggression is being displayed to anyone who speaks with inconsiderate drivers
- parking on zig-zags!?!
- putting children's lives at risk

This behaviour is becoming unacceptable and *before* there is a very serious incident, take note of WHERE you are parking (if you have to take your car) and be courteous to other drivers, parents, teachers and anyone who politely asks you to move!!

Call Centre Issues

North Yorkshire Police are aware that there are issues with their Call Centre in that calls are not always answered in a timely manner.

Sadly, these issues are NOT new, but the Police Service is trying very hard to address them. If you have any complaints about dialling 101, it is possible to place a complaint by visiting the North Yorkshire Police website, looking at the top of the web page by looking for "contact us" - https://northyorkshire.police.uk/contact/complain-to-us/ - and follow instructions and/or download their complaints form at the bottom of their page.

Defibrillators

General discussion took place on the sites for defibrillators and whether it was best to have them outside or inside. The usual site for one is outside for easy 24/7 access in case of an emergency – placement inside could mean delay if the area is locked; also, old telephone boxes are being used as they can be easily maintained.

Speeding/Volume of Traffic

As our beautiful villages become better known we are all experiencing an increase in traffic volume which in turn has a knock-on effect for other road users and residents alike. PS Regan agreed to speak with Mr Andy Naylor (NYCC Highways) to find out how the problem (s) can be addressed as it is starting to have a serious impact on quality of life in at least two Villages in our area (East Ayton – Castlegate and Wykeham) and there is a possibility of introducing 20 mph zones if these are permitted. PS Regan agreed to carry out enquiries on Member Council's behalf.

Poaching

Historically in the autumn incidents of poaching increase. PS Regan explained that there is a Rural Task Force (RTF) within North Yorkshire Police with PCSO Simon Clapcott being part of the RTF, see https://northyorkshire.police.uk/what-we-do/tackling-crime/rural-cross-border-crime/ for works on the RTF. It is possible now to download an app for smartphones for North Yorkshire Community Messaging – see the top of page 7 of this newsletter for how to download the app.

But you can also help yourself – ensure you remove any tools from your vehicles overnight; ensure your buildings/outbuildings are secure and that you have adequate dusk to dawn lighting and install a good brand of CCTV.

In addition, there is a 24/7 Response team and the area has been regularly patrolled by Police Officers and members of the Road Policing Group (RPG).

These Officers can all be contacted by telephoning **101** which is an automated switchboard that gives the following options: -

- 1. Report a crime or incident or provide information;
- 2. If you know the name of the person or department you wish to speak to;
- 3. To speak to custody.

Police can also be contacted by email — SNAfileyeastfield&rural@northyorkshire.pnn.police.uk — but please be advised — this email address is NOT for reporting crimes; these should be given by calling 101 or 999 You can also follow your local Safer Neighbourhood Officers on Twitter — @NYP_FileySNA

Local intelligence is **very** important for the Police; it can save them many man-hours and help to hone resources so I would urge you to **report any and all incidents** no matter how trivial you may think they are (they may be the final piece in a complicated jig-saw) and call the Police immediately – don't wait or think that someone else will have done it, they would far rather have an incident reported a number of times than not at all!

In a day and age where everything is judged on performance and results – crimes cannot be detected if not reported and we need the dedicated Officers we have now to continue to keep us safe!

So please don't ignore it - REPORT it!
